HŽ INFRASTRUKTURA d.o.o. has applied for financing from the World Bank toward the cost of the Sustainable Croatian Railways in Europe Project and intends to apply part of the proceeds for consulting services to be provided to HŽ Infrastruktura d.o.o., and under the supervision of the Ministry of Maritime Affairs, Transport and Infrastructure (MMATI).

The consulting services (“the Services”) include Service of Geotechnical Supervision with Quality Control over Works Performance on the Repair of Cuts on the M202 Zagreb GK-Rijeka line. The detailed Terms of Reference for the above referenced consulting services are posted on the website of HŽ Infrastruktura d.o.o. at www.hzinfra.hr.

HŽ Infrastruktura d.o.o. now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. **The shortlist criteria are:**

1. Company profile, organization and staffing
2. Details of experience or similar assignments undertaken in the previous four years, including a reference list providing information on name of assignment, cost, duration, location, client, and contact details for enquiring references as relevant. A list of major contracts on provided services of technical supervision and control testing of works which are by type and quantity comparable to the activities which are the object of this supervision and which were provided in 2014 and during 3 (three) years prior to 2014.
3. Confirmation of availability of the Key Experts with the required qualifications as indicated in detail in the terms of reference:
 - at least 1 (one) certified graduate civil engineer
 - at least 1 (one) certified graduate engineer in geology

Foreign tenderers shall submit confirmations that the degrees of their employees have been validated in the Republic of Croatia and they shall adhere to the valid rules which regulate the work and residence of foreigners in the Republic of Croatia.

The consulting services (“the Services”) include the following consulting services to be provided to HŽ Infrastruktura d.o.o.:

The service provider is obliged to carry out all control testing arising from the conditions of design documentation, and in line with special Regulations; it shall monitor that the obtained results are in line with the requirements of the project regarding the required quality of materials and works; it shall deliver to the representative of the buyer monthly reports on carried out activities; upon completion of all works, it shall draft a final report with enclosed results of published control testing.

The geotechnical supervision engineer carries out its duties in line with the laws and the Regulation on Expert Supervision Performance; it carries out harmonization and reviews completed works of the Contractor for a monthly calculation period; it continuously carries out control over works' supervision, as well as the control of attesting documentation and that the obtained test results and condition in the field match what was foreseen by the project. It informs the designer, chief supervising engineer and representative of the buyer of any deviations.

The service of geotechnical supervision with quality control is necessary for the entire duration of works' performance on repairs of cuts until the positive concluded technical inspection and takeover of the facilities, and all according to the detailed design and enclosed tender documentation.

The implementation period of this assignment is 270 working days. The Expression of Interest must be accompanied by a completed Contact Sheet. One original and two copies of the Expression of Interest in English shall be submitted to the Client in an envelope marked Expression of Interest for HZ Infrastructure for : *Service of Geotechnical Supervision with Quality Control over Works Performance on the Repair of Cuts on the M202 Zagreb GK-Rijeka line.*

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's "Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits and Grants by World Bank Borrowers" dated January 2011 (revised July 2014). ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest. In addition, please refer to the following specific information on conflict of interest related to this assignment as per paragraph 1.9 of Consultant Guidelines.

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications. The "association" may take the form of a Joint Venture or a sub consultancy. In case of a Joint Venture (JV), all members of the JV will be evaluated jointly for the purpose of short listing and shall be jointly and severally liable for the assignment and shall sign the contract in case of award is made to that JV group. Interested consultants should clearly indicate the structure of their "association" and the duties of the partners and sub consultants in their application. Unclear expression of interests in terms of "in association with" and/or "in affiliation with" and etc. may not be considered for short listing. Keeping one expression of interest per firm as principle, a consultant firm may decide whether it wishes to participate as a sub consultant or as an individual consultant or as a partner in a joint venture. Please note that a firm shall submit only one expression of interests in the same selection process either individually as a consultant or as a partner in a joint venture. No firm can be a sub consultant while submitting an expression of interests individually or as a partner of a joint venture in the same selection process. A firm, if acting in

the capacity of sub consultant in any consultant or JV, may participate in more than one consultant, but only in the capacity of a sub consultant.

A Consultant will be selected in accordance with the Selection Based on the Consultants Qualifications (CQS) method set out in the Consultant Guidelines.
